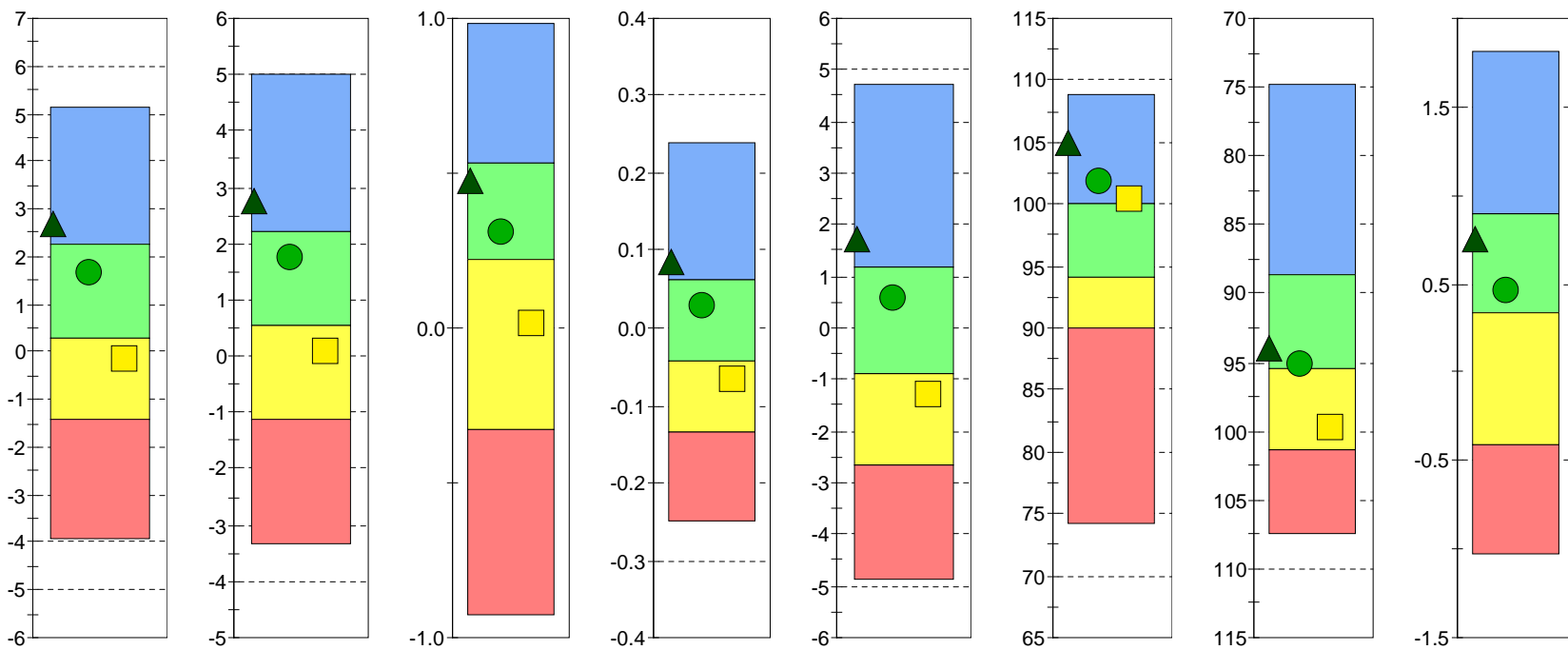

MARCH 31, 2015 TO MARCH 31, 2020**



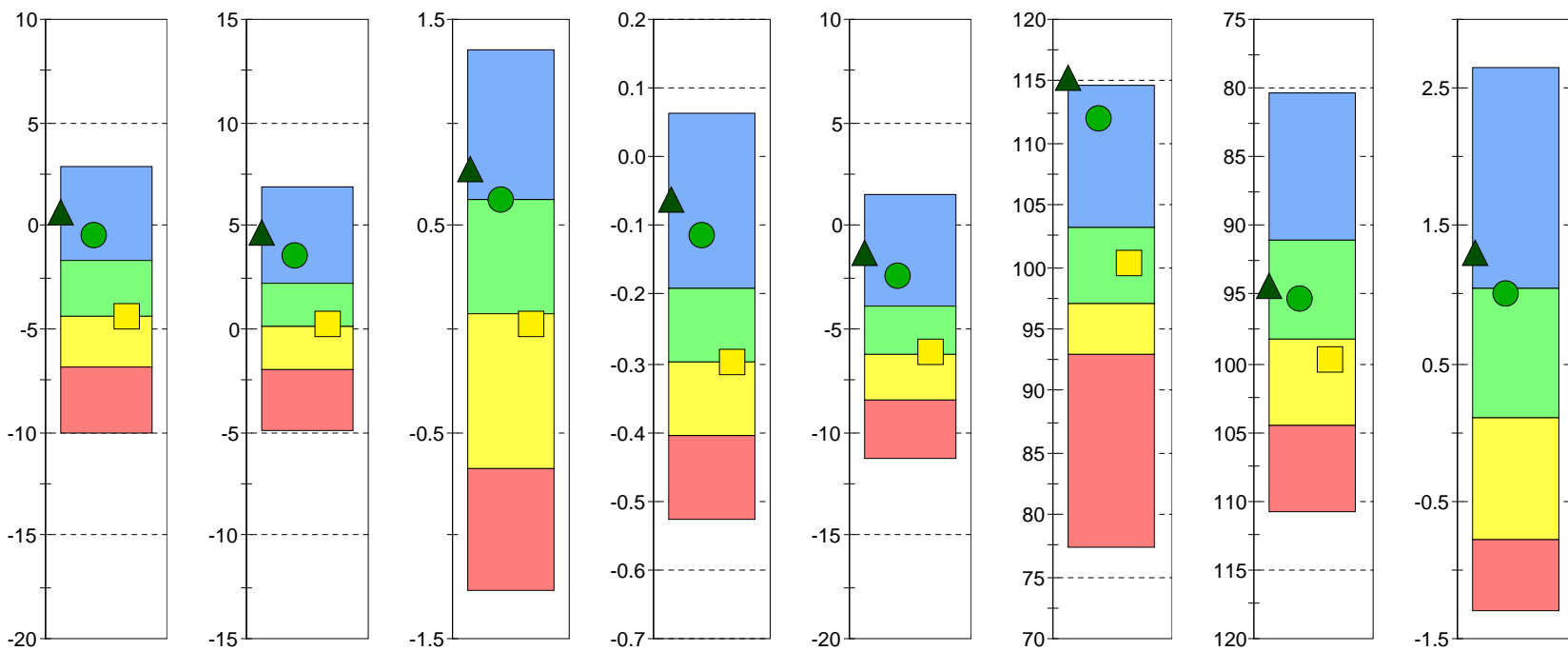

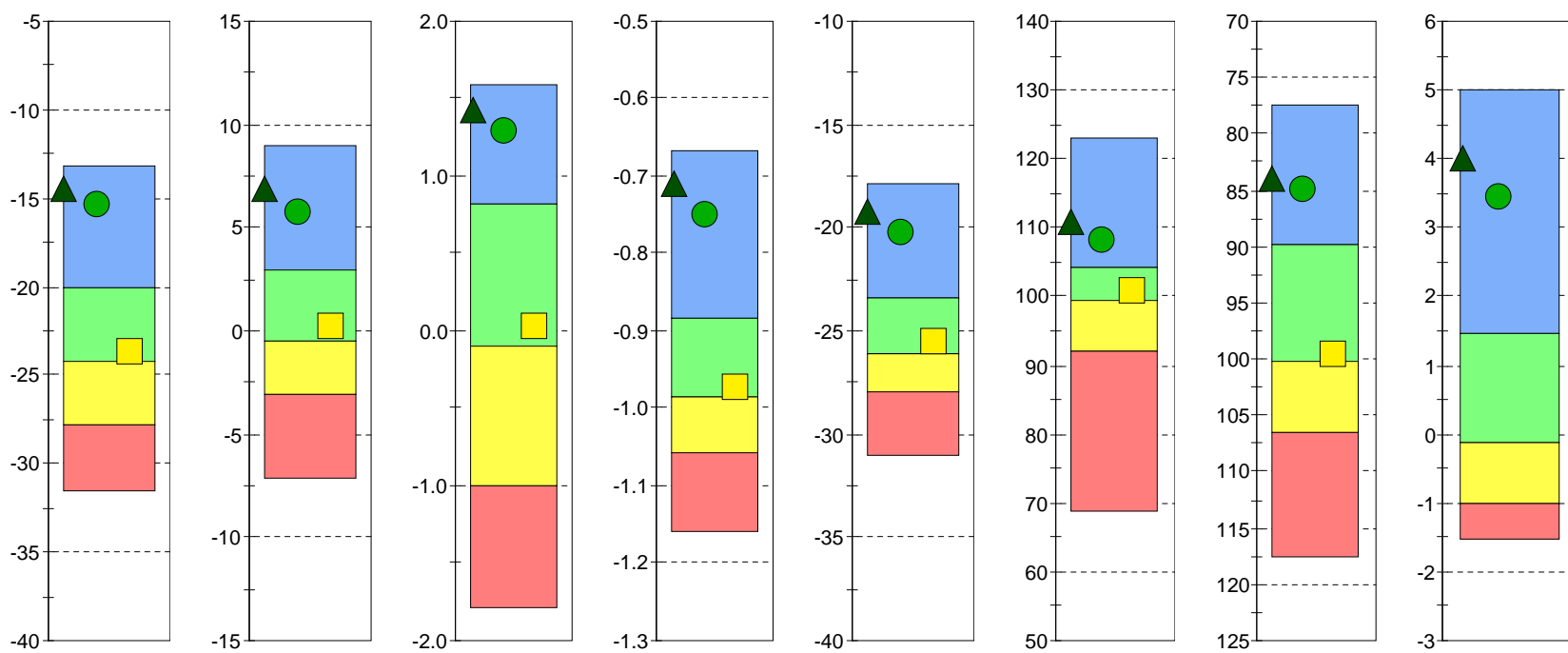
